COUNT 1: FIRST DEGREE MURDER, A
CLASS 1 FELONY (Ali Thoban Alebadi)

The Grand Jurors of Maricopa County, Arizona, accuse ALI THOBAN ALEBADI, on August 12, 2026, charging that in Maricopa County, Arizona:

COUNT 1:

ALI THOBAN ALEBADI, on or about March 22, 2026, acting either alone or with one or more other persons, committed or attempted to commit Unlawful Flight From Pursuing Law Enforcement Vehicle, A.R.S. §28-622.01, and in the course of and in furtherance of such offense, or immediate flight from such offense, ALI THOBAN ALEBADI or another person caused the death of Eva Odette Puente Ravelo, in violation of A.R.S. §§ 13-1101, 13-1105, 28-3001, 28-3004, 28-3005, 28-3304, 28-3315, 13-701, 13-702, 13-751, 13-752 and 13-801.

COUNT 2:

ALI THOBAN ALEBADI, on or about March 22, 2026, without premeditation, under circumstances manifesting extreme indifference to human life, recklessly engaged in conduct which created a grave risk of death and thereby did cause the death of Eva Odette Puente Ravelo, in violation of A.R.S. §§ 13-1101, 13-1104, 13-710, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a motor vehicle, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 3:

ALI THOBAN ALEBADI, on or about March 22, 2026, using a motor vehicle, a deadly weapon or dangerous instrument, intentionally, knowingly or recklessly did cause a physical injury to Omar Sanchez Gutierrez, in violation of A.R.S. §§ 13-1203, 13-1204, 28-3001, 28-3004, 28-3304, 28-3305, 28-3315, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a motor vehicle, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 4:

ALI THOBAN ALEBADI, on or about March 22, 2026, using a motor vehicle, a deadly weapon or dangerous instrument, intentionally, knowingly or recklessly did cause a physical injury to Douglas Edwin Kluender, in violation of A.R.S. §§ 13-1203, 13-1204, 28-3001, 28-3004, 28-3304, 28-3305, 28-3315, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a motor vehicle, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 5:

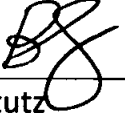
ALI THOBAN ALEBADI, on or about March 22, 2026, while driving a vehicle willfully fled or attempted to elude a pursuing official law enforcement vehicle which was appropriately marked to show that it was an official law enforcement vehicle and was being operated in a manner described in A.R.S. § 28-624(C), in violation of A.R.S. §§ 28-622.01, 28-624(C), 28-3001, 28-3304, 28-3305, 28-3315, 13-701, 13-702, and 13-801.
