EXUM 18784 OFFENSE REPORT THEFT OF MEANS OF TRANSPORTATION I AM CURRENTLY ASSIGNED AS A DETECTIVE TO THE GLENDALE POLICE DEPARTMENT (GPD) GATEWAY INVESTIGATIONS TEAM (GIT) AND WORK OUT OF THE GATEWAY POLICE SUBSTATION LOCATED AT 6261 N 83RD AVE. MY RESPONSIBILITIES INCLUDE INVESTIGATING BURGLARIES, THEFT, AUTO THEFT, TRAFFICKING IN STOLEN PROPERTY CASES, ARSON, AS WELL AS OTHER TYPES OF CRIMES. I AM ALSO ASSIGNED THE GLENDALE POLICE DEPARTMENT'S SWAT TEAM. IN BOTH OF MY ASSIGNMENTS I HAVE RECEIVED AND CONTINUE TO RECEIVE TRAINING IN HIGH-RISK ARREST TACTICS. DURING THE MONTH OF JULY, I HAD NOTICED AN UPTICK IN KIA AND HYUNDAI VEHICLE THEFT, NEAR THE AREA OF 6700 W. MARYLAND AVE. IRONICALLY, AN ADULT MALE SUBJECT IDENTIFIED AS address LIVING AT 66 su...W. PECK CALLED 911 TO REPORT HIS SON, license # HAD BEEN SNEAKING OUT OF THE HOUSE DURING NIGHTTIME HOURS (DRS 26028269 AND 26028960). HE ALSO REPORTED HIS SON IS KNOWN TO BE INVOLVED WITH VEHICLE THEFT OF KIA'S AND HYUNDAI. DURING THIS TIME, GLENDALE PROPERTY CRIMES DETECTIVES TO INCLUDE MYSELF BEGAN TO MONITOR NUMEROUS CALLS FOR SERVICE INVOLVING KIA'S AND HYUNDAI'S BEING STOLEN IN THE AREA. ON 08/04/2026 GLENDALE POLICE RECEIVED A CALL FOR SERVICE INVOLVING TWO WHITE MALES WEARING HOODIES DRIVING ERRATICALLY IN A STOLEN KIA OPTIMA. DURING THIS CALL FOR SERVICE, THE SUSPECTS WERE NOT LOCATED, BUT THE VEHICLE WAS RECOVERED NEAR 6300 N 65TH DR. THIS VEHICLE WAS IDENTIFIED AS A 2018 WHITE KIA OPTIMA (license #). ON 08/05/2026 DURING EARLY MORNING HOURS, GLENDALE POLICE RECEIVE THE CALL FOR SERVICE REPORTING A SUSPICIOUS VEHICLE, WHICH WAS DESCRIBED TO BE A STOLEN KIA OPTIMA. THIS VEHICLE WAS IDENTIFIED AS A 2012 WHITE KIA OPTIMA (license #). WHILE THE WITNESS WAS WAITING FOR POLICE TO ARRIVE, A SIMILAR VEHICLE, PULLED UP WITH TWO JUVENILE WHITE MALES WEARING HOODIES. THE PASSENGER OF THIS VEHICLE APPROACHED THE PARKED VEHICLE AND WAS CHASED

OFF BY THE WITNESS. THE VEHICLE THEY HAD ARRIVED IN WAS A STOLEN KIA OPTIMA DESCRIBED TO BE DRIVING ERRATICALLY DOING DONUTS IN A NEIGHBORHOOD CUL-DE-SAC. THE VEHICLE THE SUSPECTS ARRIVED IN WAS LATER FOUND TO ALSO BE STOLEN FROM THIS AREA. THIS VEHICLE WAS IDENTIFIED AS A 2013 WHITE KIA OPTIMA (license #).

FOR FURTHER DETAILS FOR THE INCIDENTS ON 08/04/2026 – 08/05/2026 PLEASE REFER TO GLENDALE REPORT NUMBERS: 26030818, 26030931, 26030940 AND 26030997. THIS WILL PROVIDE FURTHER INFORMATION ON WHERE THE VEHICLES WERE STOLEN, RECOVERED AND IF THERE WAS OTHER EVIDENCE FOUND.

ON 08/10/2026 DURING NIGHTTIME HOURS GLENDALE PROPERTY CRIMES DETECTIVES LOCATED ANOTHER STOLEN KIA OPTIMA IN THE LISTED AREA AND BEGAN SURVEILLANCE. THIS VEHICLE WAS FOUND TO BE A WHITE KIA OPTIMA REPORTED AND LATER RECOVERED UNDER GLENDALE REPORT NUMBER 26031320. THIS VEHICLE WAS IDENTIFIED AS A WHITE 2015 KIA OPTIMA (license #).

ON 08/12/2026 AT APPROXIMATELY 0745 HOURS, GLENDALE POLICE RECEIVED A CALL FOR SERVICE OF A KIA OPTIMA DRIVING ERRATICALLY IN THE AREA OF 6500 W. ROSE. THIS VEHICLE WAS LATER IDENTIFIED AS A MAROON KIA OPTIMA (address).

POLICE ARRIVED TO THE AREA AND FOUND THE VEHICLE UNOCCUPIED AND PARKED IN A WAY WHICH DEPICTED THE VEHICLE WAS PARKED ABRUPTLY. POLICE CONTINUED TO RECEIVE CALLS FOR SERVICE OF TWO SKINNY BUILT, YOUNGER WHITE MALES, WEARING HOODIES, RUNNING THROUGH THE AREA, JUMPING FENCES AND TRESPASSING INTO BACKYARDS. IT SHOULD BE NOTED, THIS WAS THE SAME DESCRIPTION FOR THE MALE SUSPECTS INVOLVED IN THE STOLEN VEHICLES ON 08/04/2026 AND 08/05/2026.

UTILIZING A POLICE DRONE THE TWO SUSPECTS WERE LOCATED IN THE BACKYARD OF 63 s. N. 65 DRIVE. WHILE POLICE WERE ESTABLISHING RESOURCES IN THE AREA. THE TWO SUSPECTS WERE SEEN HIDING UNDER AN RV TRAILER ON THE LISTED PROPERTY. A CONTACT TEAM WAS DEVELOPED AND APPROACHED THE TWO SUSPECTS UNDER THE RV TRAILER AND GAVE LOUD CONCISE COMMANDS TO GIVE UP PEACEFULLY. POLICE ALSO TOLD THE SUSPECTS THAT THEY WERE UNDER ARREST AT THIS TIME. DURING THIS PORTION, I WAS ASSIGNED AS A SOUTHERN PERIMETER UNIT WITH LESS LETHAL CAPABILITIES.

AS THE SOUTHERN PERIMETER RESOURCE I BEGAN TO LOOK OVER THE RETAINING WALL NEAR WHERE THE SUSPECTS WERE DESCRIBED TO BE. AT THIS POSITION I COULD SEE WHO WAS LATER IDENTIFIED AS suspect name juvenile UNDER THE TRAILER. suspect... WAS MANIPULATING SOMETHING WITH HIS HANDS BUT I COULD NOT TELL WHAT IT WAS.

THE TWO SUSPECTS IMMEDIATELY CRAWLED OUT FROM UNDER THE RV TRAILER AND ATTEMPTED TO RUN EASTBOUND INTO A NEIGHBORING APARTMENT COMPLEX. UTILIZING MY DEPARTMENT LESS LETHAL FN303 LAUNCHER, I DEPLOYED ONE PAVA ROUND AT A NEARBY STRUCTURAL POST IN AN ATTEMPT TO DISPERSE THE IRRITANT TO PREVENT THE SUSPECTS FROM FURTHER FLEEING EASTBOUND. THE SUSPECTS GAVE UP AND WERE TAKEN INTO CUSTODY WITHOUT FURTHER INCIDENT BY THE IMMEDIATE ACTION TEAM WITHIN THE LISTED PROPERTY.

ONE OF THESE SUSPECTS TAKEN INTO CUSTODY WAS IDENTIFIED AS THE YOUNGER WHITE MALE WHO LIVES AT 66 a... W. PECK, address .

POLICE THEN CONDUCTED A ONE-ON-ONE IDENTIFICATION WITH BOTH WITNESSES FROM THIS MORNING'S INCIDENT. ONE WITNESS POSITIVELY IDENTIFIED THE TWO AS THE ONES HE OBSERVED, RUNNING AND JUMPING FENCES. THE OTHER WITNESS IDENTIFIED BOTH MALES BASED ON THEIR CLOTHING, FOR THE SUBJECTS OBSERVED IN THE ABRUPTLY PARKED STOLEN VEHICLE. PLEASE SEE OFFICERS BURELL AND COLUMN'S SUPPLEMENTAL REPORT FOR FURTHER INFORMATION ON THE ONE ON ONE IDENTIFICATIONS.

POLICE CONTACTED THE VICTIM WHO LIVES AT 63 s. N. 65 DRIVE. THIS VICTIM STATED HE DOES DESIRE PROSECUTION FOR THE CRIMINAL TRESPASSING IN HIS RESIDENTIAL FENCED IN PROPERTY.

BOTH SUBJECTS WERE TRANSPORTED TO THE GLENDALE CITY JAIL, WHERE I CONDUCTED POST MIRANDA INTERVIEWS.

DURING A POST MIRANDA INTERVIEW WITH suspect name juvenile, HE STATED HE UNDERSTOOD HIS RIGHTS AND WAS WILLING TO GIVE THEM UP AND SPEAK TO ME. I IMMEDIATELY BEGAN TO QUESTION HIM ABOUT THIS MORNING'S INCIDENT. HE EXPLAINED HE KNEW HE WAS IN JAIL AND UNDER ARREST CURRENTLY FOR BEING IN A STOLEN CAR. HE STATED HE KNEW IT WAS STOLEN BECAUSE NOT ONLY DOES HE KNOWS suspect name juvenile TO STEAL THESE VEHICLES, BUT HE ALSO OBSERVED THE IGNITION TO BE DAMAGED. I ASKED APPROXIMATELY HOW MANY TIMES HE HAS BEEN INVOLVED IN THESE INCIDENTS. suspect name juvenile STATED HE BELIEVED IT'S BEEN APPROXIMATELY EIGHT TIMES OVER THE COURSE OF SUMMER BREAK. HE STATED IT HAS ALWAYS BEEN WITH suspect name juvenile. suspect name juvenile ADVISED suspect nam... UTILIZES A SCREWDRIVER TO POP THE REAR WINDOW. HE STATED suspect name juvenile THEN ENTERS THE VEHICLE THROUGH THE WINDOW AND RIPS OFF THE STEERING COLUMN TO GAIN ACCESS TO THE IGNITION. suspect na...

[suspect name ...] THEN UTILIZES A FLATHEAD SCREWDRIVER TO DAMAGE THE IGNITION AND START THE VEHICLE. [suspec... STATED HE HAS NEVER BEEN THE ONE TO STEAL THE CAR AS HE IS TERRIFIED OF WHAT HIS MOTHER WOULD DO TO HIM. [suspec... DID ADMIT THAT HE DOES THIS WITH [suspect na...] FREQUENTLY AS IT IS AN ADRENALINE RUSH. [suspec... DESCRIBED THAT [suspect na...] ONLY PICKS KIA'S AND HYUNDAI'S THAT ARE KEY TO START, AS THE PUSH TO START VEHICLES ARE UNABLE TO BE STOLEN.

I ASKED [suspect name juvenile] ABOUT LAST WEEK'S INCIDENT IN THE AREA OF 7200 W. CITRUS WHERE THE NEIGHBOR HAD YELLED AT THEM. [suspect name juvenile] EXPLAIN THAT NIGHT ON 8/4/26 INTO THE MORNING OF 8/5/26, [suspect name juvenile] AND HIMSELF HAD STOLEN THREE TOTAL CARS. HE DESCRIBED THEM TO BE ALL KIA OPTIMA'S ONE WAS BLACK IN COLOR, RED IN COLOR AND WHITE IN COLOR. HE STATED THESE VEHICLES WERE STOLEN FROM NEARBY APARTMENT COMPLEXES. [suspect name juvenile] ADVISED HE DOES REMEMBER THE NEIGHBOR YELLING AT THEM WHILE THEY WERE RETURNING TO THE SECOND STOLEN VEHICLE. HE DID ADMIT HE ALSO REMEMBERS [suspect na...] TRYING TO DRIFT THE VEHICLE IN A CUL-DE-SAC BUT SPECIFIED, HE WAS THE FRONT SEAT PASSENGER DURING THIS INCIDENT.

I ASKED [suspect name juvenile] LAST NIGHT AND THIS MORNING, 8/12/26. [suspect name juvenile] ADVISED THERE WERE THREE TOTAL CARS TODAY. HE DESCRIBED THEM TO BE A WHITE KIA OPTIMA, A BLACK KIA OPTIMA AND A DARK RED KIA OPTIMA, WHICH IS THE ONE THEY FLED FROM. [suspect name juvenile] STATED LAST NIGHT [suspect name juvenile] CALLED HIM TO SNEAK OUT WHICH HE AGREED TO. [suspect name juvenile] PICKED HIM UP FROM HIS RESIDENCE IN THE STOLEN VEHICLE, WHICH HE SAID HE KNEW IT WAS STOLEN BECAUSE OF THE IGNITION WHICH HE COULD SEE FROM WHERE HE WAS SEATED. I ASKED WHY THEY ABRUPTLY PARKED THE MAROON KIA AND FLED. [suspect name juvenile] STATED THEY WERE IN A RUSH TO GET READY FOR SCHOOL, WHICH IS WHY THEY PARKED THE VEHICLE CLOSE ENOUGH TO HOME BUT FAR ENOUGH FROM HOME TO NOT BE ASSOCIATED WITH IT. HE STATED WHEN THEY PARKED THE VEHICLE, AND AN UNKNOWN MALE NEARBY YELLED AT THEM, ASKING THEM WHAT THEY WERE DOING PROMPTING THEM TO RUN. [suspect name juvenile] STATED THEY WERE ATTEMPTING TO RUN AND GET TO THE BLACK KIA OPTIMA PARKED IN THE DIRT LOT AND OR [suspect na... RESIDENCE. I ASKED HOW [suspect name juvenile] STOLE THE VEHICLES TONIGHT AND HE STATED THE THREE VEHICLES WERE STOLEN WITH THE SAME METHOD HE DESCRIBED EARLIER WITH A FLATHEAD SCREWDRIVER. [suspec... ADVISED [suspect name juvenile] HAD THE PHONE CHARGERS IN HIS POSSESSION AS SOMETIMES THEY ARE USED TO START THE VEHICLES.

THIS ULTIMATELY CONCLUDED THE POST MIRANDA INTERVIEW WITH [suspect name juvenile].

AT APPROXIMATELY 0 932 HOURS, I BEGAN TO CONDUCT A POST MIRANDA INTERVIEW WITH [suspect name juvenile]. [suspect name juvenile] STATED HE UNDERSTOOD ALL OF HIS RIGHTS AND WANTED TO GIVE THEM UP AND SPEAK WITH ME.

DURING THIS INTERVIEW I ASKED [suspect name juvenile] WHY HE BELIEVED TO BE IN JAIL. [suspect name juvenile] STATED HE HAD BEEN STEALING CARS FOR APPROXIMATELY TWO MONTHS. I BEGAN TO ASK ABOUT THE INCIDENT ON 08/05/26. [suspect name juvenile] STATED ON THIS NIGHT, HE STOLE TWO VEHICLES ACCOMPANIED BY [suspect name juvenile] IN THE AREA OF 5900 W. BETHANY HOME ROAD. [suspect name juvenile] ADVISED HE DOES REMEMBER ATTEMPTING TO DRIFT THE VEHICLE IN THE NEIGHBORHOOD WHERE THEY WERE CONFRONTED BY A NEIGHBOR WEARING A RED SHIRT.

I ASKED [suspect name juvenile] ABOUT TODAY'S INCIDENT, 8/12/26. [suspect name juvenile] EXPLAINED EARLIER THIS MORNING THAT HIM AND [suspect name juvenile], WERE WALKING AROUND THE AREA OF 6500 W. ROSE LANE. IN THIS AREA, THEY LOCATED A BLACK KIA OPTIMA IN A DIRT LOT AND ATTEMPTED TO STEAL IT. [suspect name juvenile] EXPLAINED THEY OBSERVED THE IGNITION TO ALREADY BE DAMAGED. HE SAID WHEN HE ATTEMPTED TO START IT WITH A SCREWDRIVER, THE VEHICLE WOULD NOT START, WHICH PROMPTED THEM TO CONTINUE WALKING.

[address] STATED THEY THEN WALKED TO 64[s... N. 67TH AVE. WHERE THEY LOCATED A WHITE KIA OPTIMA. [suspect name juvenile] STATED HE STOLE THIS VEHICLE BY BREAKING THE REAR WINDOW WITH A SCREWDRIVER THEN USED THE SAME SCREWDRIVER TO REMOVE THE STEERING COLUMN AND DEFEAT THE IGNITION. [address] ADVISED THEY DROVE THE WHITE KIA OPTIMA TO THE AREA OF 68[s... WHERE THEY OBSERVED WHAT WAS LATER DETERMINED TO BE A SILVER HYUNDAI ELANTRA. [suspect name juvenile] TOLD DETECTIVES. HE STOLE THE SILVER ELANTRA WITH THE SAME METHOD HE DESCRIBED ABOVE. HE THEN DROVE THE ELANTRA TO THE AREA OF 51[s... N. 65 AVE WHERE THE ELANTRA BROKE DOWN AND WOULD NOT START AGAIN. THIS PROMPTED [address] TO WALK TO THE ARCHES APARTMENTS LOCATED AT 62[a... N. 63 AVE.

AT 62[s... [suspect name juvenile] AND TWO LOCATED A DARK RED OR MAROON KIA OPTIMA, WHICH THEY STOLE WITH THE SAME METHOD USING A SCREWDRIVER. [suspect name juvenile] STATED HE TOOK [suspect name juvenile] HOME AND DROVE HIMSELF HOME AT THIS POINT IN THE NIGHT.

[suspect name juvenile] STATED LATER IN THE NIGHT HE AGAIN PICKED UP [suspect name juvenile] IN THE MAROON KIA OPTIMA AS THEY WANTED TO GO DRIFTING. THIS CONTINUED TO FOR SOME TIME UNTIL IT WAS TIME TO GET READY FOR SCHOOL, WHICH IS WHY THEY PARKED THE VEHICLE WHERE THEY LEFT IT.

I ASK [suspect name juvenile] WHY THEY HAD BEGUN TO RUN FROM THE MAROON KIA OPTIMA. [suspect name juvenile] STATED THEY WERE IN A RUSH TO MAKE IT HOME ON TIME TO GET READY FOR SCHOOL. [suspect name juvenile] THEN ADVISED

WHILE HIM AND suspect name juvenile WERE JUMPING FENCES THEY OBSERVED TWO MARKED GLENDALE PATROL OFFICERS AT WHICH POINT THEY KNEW THEY WERE IN TROUBLE. suspect name juvenile ADVISED AT THIS POINT THEY BEGAN TO HIDE UNDER THE TRAILER TO FLEE POLICE.

I ASKED suspect name juvenile HOW HE DETERMINES WHICH VEHICLES HE IS GOING TO STEAL. HE STATED IF THE VEHICLE NEEDS A KEY, IT IS GOOD TO GO, IF THE VEHICLE IS PUSHED TO START, HE CANNOT STEAL THOSE ONES.

I BEGAN TO ASK suspect name juvenile ABOUT THE SOCIAL MEDIA ACCOUNT, WHICH WAS POSTING VIDEOS OF KIA'S AND HYUNDAI'S BEING STOLEN AND DRIVEN RECKLESSLY. suspect name juvenile ADVISED HE IS INVOLVED WITH THIS ACCOUNT AND HAS LOGGED INTO IT TIMES BEFORE. HE STATED IT IS A SHARED ACCOUNT AMONGST A GROUP OF KIDS WHO DO THE SAME THING. address STATED THE VIDEO OF A CRASHED KIA SOUL, AND ONE OF THE FIRST VIDEOS OF TWO STOLEN VEHICLES ON A MOUNTAIN TOP WERE POSTED BY HIMSELF.

DETECTIVES RESPONDED TO 51 s... N. 65TH AVE. WHERE THEY IN FACT LOCATED THE HYUNDAI ELANTRA, WHICH HAD NOT BEEN REPORTED STOLEN YET. THIS VEHICLE WAS NOT ONLY RECOVERED, BUT THE VICTIM WAS CONTACTED AND WANTED TO PRESS CHARGES. PLEASE REFER TO GLENDALE REPORT NUMBER 26032087 FOR FURTHER INFORMATION ON THIS VEHICLE AND ITS RECOVERY.

suspect name juvenile WAS BOOKED INTO THE GLENDALE CITY JAIL FOR FIVE COUNTS OF THEFT OF MEANS OF TRANSPORTATION, AND ONE COUNT OF ATTEMPTED THEFT OF MEANS OF TRANSPORTATION. HE WAS ALSO CHARGED WITH POSSESSION OF BURGLARY TOOLS AS HE WAS FOUND TO HAVE TWO PHONE CHARGERS IN HIS POSSESSION. HE WAS ALSO CHARGED WITH CRIMINAL TRESPASSING IN THE RESIDENTIAL FENCED IN YARD WHICH DETECTIVES TOOK HIM INTO CUSTODY IN. THESE CHARGES WERE ACCRUED FROM 08/05/26 AND 08/12/26.
