The Grand Jurors of Maricopa County, Arizona, accuse JEAN ZINTZ, on August 27,
2026, charging that in Maricopa County, Arizona:

COUNT 1:

JEAN BRANDO ZINTZ, on or about August 19, 2026, without lawful authority, knowingly did control Carly Jayne Feddersen, Tyler Hal Johnson, Ninabah Winton, and/or the Mesa Arts Center's jewelry, of a value of \$4,000 or more but less than \$25,000, knowing or having reason to know that the property was stolen, in violation of A.R.S. §§ 13-1801, 13-1802, 13-701, 13-702, and 13-801.

COUNT 2:

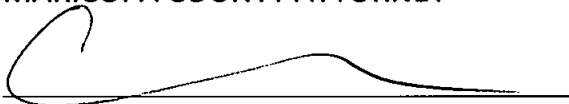
JEAN BRANDO ZINTZ, on or about August 19, 2026, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure of the Mesa Arts Center, located at 1 E. Main St, Mesa, Arizona 85201, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

COUNT 3:

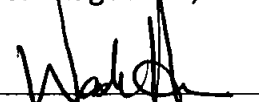
